#### Introduction.

Government vide G.O(MS) No 38/2022/Taxes dated 13-06-2022 had sanctioned a 5-line IMFL blending and bottling plant in the Company. ### **Objective**

MDL is inviting expressions of interest from experienced professionals and firms to act as a consultant for a period of 1 year or till commencement of commercial production to provide expertise implementing the blending and bottling unit and in enhancing the operational efficiency of the company. The selected consultant will assist in implementation of the IMFL production unit by M/S KEL and suggest in optimizing the production processes, assuring quality control, streamlining supply

chain management, and ensuring compliance with applicable regulations.

## **Eligibility Criteria**

To be eligible for consideration, the consultant must meet the following criteria:

**Qualification:** Minimum a Graduate Engineer preferably Chemical, Mechanical or Production & Planning.
